RESOLUTION


NOW THEREFORE, BE IT RESOLVED:

2. Trustee D. Price hereby moves to exclude Troy Township from Community Development Block Grant (CDBG) Program Urban County Qualification, Fiscal Years 2025 -2027, with the option to opt back in years 2 or 3 if Troy Township so desires.


Trustee Morris seconded the motion.
