New Business:

- Trustee Price made a motion to appropriate the remaining balance of the American Cares Act funds for the purchase of a new road mower. The balance in the fund as of November 18, 2024, is \$36,390.23. Total purchase price for the mower is estimated to be \$75,430.00. The remaining balance needed, up to \$41,000.00, Trustee Price made the motion to come out of the general fund. Trustee Morris made a second on the motion. Roll Call Vote: All Voting Yes. The Motion Passed.
- Trustee Morris made a motion to appropriate \$5,000.00 for Long EDA and Frost Brown for additional TIF work. Trustee Lehner made a second on the motion. Roll Call Vote: All Voting Yes. The Motion Passed.
- Trustee Morris made a motion to terminate the employment of Kevin Green as of November 30, 2024. Trustee Lehner made a second on the motion. Roll Call Vote: All Voting Yes. The Motion Passed.
- Discussion was held on the annexation of the property for Paul Price on Hills Miller Rd which will be going before the commissioners on December 19. City denied the annexation and the letter of services. Trustees will go and voice their opinion and concerns at meeting on December 19, 2024.

At 8:20 PM, Trustee Lehner motioned to enter into EXECUTIVE SESSION PER ORC 121.22(G)(2): To consider the purchase of property for public purposes, or for the sale of property at competitive bidding, if premature disclosure of information would give an unfair competitive or bargaining advantage to a person whose personal, private interest is adverse to the general public interest. Trustee Morris made a second on the motion. The Roll Call Vote: Trustee Price-yes, Trustee Morris-yes, Trustee Lehner-yes. The Motion Passed with 3-yes, 0-no, and 0-abstain votes.

At 8:40- PM, Trustee Lehner made a motion to exit Executive Session and reconvene the Regular Meeting. Trustee Morris made a second on the motion. Roll Call Vote. All Voting Yes. The Motion Passed.

Trustee Price made a motion to place Trustee Lehner as the point person if said property becomes available for sale. Trustee Morris made a second on the motion. The Roll Call Vote: Trustee Price-yes, Trustee Morris-yes, Trustee Lehner-yes. The Motion Passed with 3-yes, 0-no, and 0-abstain votes.
